Al-Anon is a gentle program.

Some of the readings may not suggest that. A newcomer's welcome that states, "You and you alone are responsible for dealing with your own pain" comes to mind. Even in the steps, having "God remove all these defects of character" initially sounded like a painful procedure.

The gentleness I have found has come from other members. My sponsor who was so lovingly in the fifth step helped me to forgive myself my faults and to appreciate my better qualities. And more recently all the members who have supported and encouraged me during my term as the inevitably imperfect editor of this newsletter.

This position has given me so much practice making amends. The newest: In my zeal to print exactly what was submitted in the December issue, I mistakenly printed a list of Trusted Servants which was sent simply to verify my information. That list, while enticingly formatted, did not include our Past Delegates — so neither did that issue. My apologies to those valued members, and anyone who was seeking their information. My gratitude to the person who so gently pointed out that omission.

Every service position is an opportunity to work the Twelfth Step, because ever facet of this fellowship is focussed on carrying the message. And Al-Anon service provides a safe, supportive community in which to practice these principles. Service has been an essential element to my recovery. As new Group Reps and Alternate Group Reps are chosen later this year, I highly recommend these positions as opportunities to move into service beyond the group. #### Minutes – Fall Assembly, October 19, 2019

#### **Opening**

Joe D. opened the meeting with the Serenity Prayer.

Reading of our Steps- Sue, Traditions- Sue, and Concepts including Warranties- Miriam

#### Welcome

Host District Welcome- Glenn, DR from District 2

Area Welcome- Joe D.

#### **Area Business**

Roll Call and Vote on Substantial Unanimity – Group Records Coordinator, Maureen M.

Maureen read Warranty 3, p. 216-217 from the Service Manual about substantial unanimity.

Roll call of number of Group Representatives present from each district:

District 1- 0, D2- 7, D3- 0, D4-0, D5-0, D6-0, D7-3, D8- 6, D9- 1, D10- 3, D11- 0, D12-7, D13-6, D14- 4,

D15-1, D16-0, D17-1, D18-1, D19-0, D20-2, D21-0, D22-0, D23-0, D24-1

There were 43 Group Reps total.

There was a motion that 2/3's be used as substantial majority. The motion was seconded.

We voted to establish a vote of 2/3s to be considered substantial unanimity (equaling 29 votes).

#### Approval of Minutes from 2019 Spring Assembly meeting – Area Secretary, Dolores M.

Minutes from the Fall 2018 Assembly were approved as published in the December 2018 issue of the Al-Anon-cer.

#### Chair's remarks and Agenda overview – Area Chairperson, Joe D.

Talk about the upcoming Election Assembly in your groups to groom a new Group Representative and Alternate GR. Get people thinking about who would like to be a coordinator of a committee? Check the requirements of the jobs.

If we forsake service, we are selling ourselves short. This is an integral part of the program-- growth through service.

#### **Confirm 2020 Area 24 Meeting Dates and Host Districts:**

Spring AWSC – March 28 (snow date April 4), host District 13

Spring Assembly – May 30, host District 10

Fall AWSC - September 26, host District 24

Fall Assembly – October 24, this is the election assembly- looking for a host

We voted to approve the dates for 2020 meetings.

#### **Area Delegate's Report** – Idalia R.

WSO Strategic Plan Update (it's on the WSO website):

In July, the board met for trustees' training on ASANA, a new online program through which the Strategic Plan strategies are managed.

Strategic Plan Goals, 3-5 yr time frame: members, public, organization (one global structure)

Objectives- 2-3 yr time frame

Strategies- 1-2 yr time frame

- Exploring hybrid meetings because of the expense of bringing everyone together.
- The 2020 International Al-Anon General Services Meeting (IAGSM) will include 3 meetings in Slovenia, Mexico and El Salvador.
- Trustee Confirmation Process is in discussion. Executive Committee Member Selection- members will serve a maximum of 3 one-year terms.
- 2019 contributions to the WSO are trending below the budget.
- Sales of Intimacy in Alcoholic Relationships and the Just for Tonight bookmark are good.
- Contributions via the Quarterly Appeal Letter are on steady downward trend. Do groups read the letter? Do groups mail it back in the Appeal envelope? Does the letter need to be "jazzed up"?
- A "Road trip" is currently happening today in Seattle. This is where the WSO staff visits an Area.
- Northeast Regional Delegate Conference (NERD) is March 13-15, 2020.
- AA International Convention with Al-Anon Participation will be in Detroit July 2-5, 2020.
   Registration is currently open. An FYI from Connie- some of the hotels are in Canada. She's not sure of transportation to meetings, etc. Make sure you know what you are signing up for.
- Al-Anon International Convention in Albuquerque, NM will be June 30- July 1, 2023.
- The theme is 2020 World Service Conference is Dreaming Big with 20/20 Vision.
- We will have two breakout sessions this afternoon on service and the appeal letter (Idalia is on a committee about the appeal letter.)

#### **Area Treasurer's Report** – Charles L.

Presentation and vote on 2020 Budget (attached)

#### • Current Financial Situation:

- As of today we have a deficit of \$4,180
- Cash balance is \$22,530
- Estimate for 2019 is we will break even, or we might lose a little.

At the spring assembly we approved an increase in Public Outreach Budget by \$4275.

#### • Proposed budget for 2020:

#### **Projecting \$19,063 Contributions and Interest**

We arrive at this figure with a look at the perspective of group contributions over the last 5 yrs (up and down). Please note that we do not project a contribution from either the spring or fall conventions, which are supposed to be breakeven events. If they have money to contribute back to the Area, then that is great, but not expected.

#### Program Expenses: Budgeted less in the 2020 budget-\$11,920

**Administrative Expenses: \$14,450** 

We are projecting about the same as last year- a \$7310 deficit (Keep in mind that this doesn't necessarily become actual.)

January 1 Reserve Funds:

WSO recommends 6 months to 1 year of operating expenses for reserve funds.

Budgeted expenses for 2020 are \$26,370

Projected Jan. 1 Bank Balance is \$22,600

Prudent Reserve is \$3370 [check this figure with Charles]

He will wait to the Spring Assembly to make a recommendation about what to send to WSO.

#### Changes in the budget from 2019 to 2020:

Decrease literature budget- by \$170 to \$400

Decrease Legal and Professional by \$200

Insurance increase by \$150

\$100 increases each for Steering Committee, WSC, and NERD

Public Outreach reverts back to its usual budget, before MTA project.

#### Projected vs. Actual

Ouestions:

Guidelines for dividing up contributions from groups. See the service manual. Groups usually support the group first, then, anything left goes to the District, AIS, Area, and WSO. Your group can decide if it's equal amounts or other percentages. Some groups also support an Alateen group.

Hosting an Assembly or AWSC were added as a line item in the Area budget. Districts do not have to absorb all the costs for room rent, food, etc.

Audit of Area Finances- We have someone auditing the Area (either a CPA we know or auditor).

#### **Maintaining Financial Stability**

Money has to keep coming into the Area to maintain things that cover the entire area- insurance, Alateen safety and training, Conventions, etc.

We have our prudent reserve.

#### **When Making Contributions:**

Write the group's WSO number on the check for your group when you submit contributions.

Personal contributions- write personal contribution on the check in the memo line.

Idalia's comments- We are successful with conventions being self-supporting.

**Area Coordinator Reports:** (as time allows before lunch, continuing in the afternoon)

#### **Technology Coordinator-** Paul:

When you use of generic email address for your service position, you can forward to your personal email address. The next service person can pick up where you left off.

We have a number of email addresses. It creates continuity. You can't send from that email address. Another option is to set up a gmail account if you don't want to use your own email. If you want a generic email address, see Paul.

#### **2019 Fall Convention Update** – Greg M. read Jami's report:

The 29th annual Fall Convention is less than a month away. Close to 200 people have already registered. "Stories of Recovery" will take place the 3rd weekend of November-15th-17th, and is being held again at the Marriott Delta hotel in Hunt Valley, MD. This convention has AA and Alateen participation. Alateen registration fees are being paid for by a generous gift from an Al-Anon member, so this convention is a great opportunity for a family recovery weekend.

The registration fee of \$120 is a great deal, as it includes three meals, many meetings, panels, special speakers, entertainment, a fellowship party with a DJ, painting, bingo, a hospitality center and more. The final date for advanced registration is November 8th. Though advanced registration is preferred for planning purposes, walk-ins are also welcome. The on-site registration fee is \$140.

Online registration and payment can be done at "tinyURL.com/AFG24fc" Mail in registration forms and the link to our block of discounted hotel rooms at \$124 a night, can be found at this same site. The program and menu can be viewed on the website.

Please make sure the convention is being announced at your meetings and spread the word of all the great things the weekend offers, including for the Alateens. A convention flyer with tear-off registration tabs can also be downloaded from the registration website. Let's keep these wonderful weekends of fellowship, fun and most of all recovery, going strong.

#### **2020 Spring Convention Update** – Marty C.

Last year's convention made \$500.

The Spring Convention will be held June 12-14, 2020 at Washington College in Chestertown, MD. The College has made a small increase in cost for 2020 in the amount of \$6.26 or \$6.56 per person, depending on the room category so the registration fees will be increased by \$5.00. The theme can't be announced until the fall convention.

The Friday Night Entertainment will be based on the movie FOOTLOOSE, Garrison M. is working on the script. We will have 300 Save the Date fliers printed to distribute at the Fall Convention. The Al-Anon Speaker will be Ellen C. from Addison, Texas. She has been in Al-Anon for over 20 years and her message is very powerful. At this point we have four Committees that do not have a Chair: Entertainment, Welcome, Hospitality and Literature.

#### **2020 AA Spring Convention Liaison** – Katie C-S:

The convention is in June next year. Encourage Al-Anon participation so that we have presence to let people know who we are.

#### **Group Records Coordinator** – Maureen M.

Reminder- if you have changes to your Group Records Form, you can make changes online with WSO or with Maureen. It's important to keep your group contact information up-to-date.

Report is the same as that given to the Fall AWSC. It is shortened here:

- 1. a. The new WSO terminology for designating a meeting as Open or Closed impacts more than 400 items in Al-Anon literature, forms and databases per WSO Group Records Office. The changeover is being performed gradually, so some literature, forms and database reports will still have the old terminology rather than the Families and Friends- Closed designational and Families, Friends, and Observers Welcome- Open meeting designation. b. AGRC Requests that all DRs verify the meeting status of their groups in the WSO Records. Many discrepancies have been discovered. Local Areas
- 2. Provided all District Representatives with the WSO records for their Districts in late July/early August for their review and updates. Received responses, from some District Representatives which were comprehensive, and no response from many others.
- 3. Received inquiry from an assistant State Fire Marshall regarding a fire at a church in Lineboro, MD where an Al-Anon meeting had been held the previous night.
- a. Explained the program to him and told him that I could verify that an Al-Anon meeting was scheduled for that date but since Al-Anon is an anonymous I would contact DR to see if anyone remembered and was willing to speak with him.
- i. DR located a person who attended, Chris, who was willing to speak with him. Provided her with his contact information.
- ii. FYI, Meeting moved to Manchester and closed this summer per group records and contacting the past and new DR for D3.
- 4. Continued to input meeting changes submitted by members for their group and, DRs for their districts. Provided new GRS and CMAs with the current Al-Anon-Cer, suggesting that they subscribe for their group, a copy of the revised record and a copy of the AGRC presentation on Group Record changes, Spring 2018 for their information/retention.
- 5. WSO now provides a weekly list of any changes that are sent to them via email that they input into the WSO database to the AGRC. AGRC reviews these transactions and when appropriate notifies the pertinent District Representative and AIS Directory Contact of the change. (Note some changes do not impact a directory or AIS's information on a group.
- 6. Completed revision of Fact Sheet on Group Records New Registrations, changes to Current Registered meetings and Annual Update actions for the September Al-Anon-Cer.
- 7. NEW: WSO has delegated the input of the Group Annual Update information to the AGRCs, so groups can now notify the AGRC rather than mail Annual Update Form back to WSO.
- 8. Notified pertinent Districts of meetings that WSO was planning on deleting after many years of no activity to validate that meetings were no longer meeting and provided feedback to WSO.
- 9. Continued to work on reducing the number of meetings in a "no mail" and "email returned" status.

#### **Insurance Coordinator-** Gil:

The Area will pay for insurance for any meeting facility you need, for workshops, meetings, etc. We have professional liability insurance, even though we are not professionals. We have insurance for AMIASs.

He works with the insurance brokers to get the most reasonable rates. It's necessary expense.

If we didn't give the facility an insurance certificate, it doesn't mean that we are not covered. If they want one, they will tell you. Our insurance certificate expires April 1 and then we get a new certificate.

If your facility or event requests a Certificate of Insurance, please forward the following information to me, gsl100@comcast.net: Name and address of building or organization, name, phone, fax, and email for contact person, date of the event, and brief description.

**Alateen Report** — Area Alateen Coordinator, Barb M. (Sarah R. is the AAPP)

• Training for Group Sponsors (AMIAS) – Five training sessions have been held in 2019. 71 AMIAS recertified and 16 new AMIAS were trained; not all the new have completed the process. This year there were a various changes to Maryland's law regarding child abuse and neglect, so training cover these. Training included a review of Alateen literature and each meeting was provided with samples of most Alateen literature so they could assess what's in use at their meetings and what to give newcomers.

Training went well. They had 5 sessions, 16 new trained in process of becoming AMAISs. She went through what Alateen literature is available and in what succession they give it out. Covered changes to MD law about abuse and neglect reports.

#### • Alateen in schools & health department centers:

- Baltimore County Public Schools (BCPS): the Alateen Area Coordinator (AAC) met with BCPS administration last year and worked out the details of the cooperative agreement required by BCPS in order to have the meetings. Presently trying to identify 4-5 AMIASs to support a meeting in a school. Some areas want a meeting but can't get AMAISes. Great service work to offer Al-Anon to kids. It's difficult to get enough qualified people available during the day.
- <u>- Wicomico County Schools</u>: One of the AMIAS in that area has contacted the school administration. The county will require a school counselor to be present. Discussions continue.

<u>Health Departments</u> – over the summer both Anne Arundel County and Baltimore County Health Departments expressed interest in Alateen. Discussions continue.

- Flyer: "Why do Al-Anon members become AMIAS? It's great service work!" In order to grow Alateen, Al-Anon members need to become **Group Sponsors**, AMIASs cannot be personal sponsors. The flyer explains the need and the process. Having more AMIAS will position the Area to be able to provide Alateen in schools and communities. Flyers are available on the table.
- **Annual recertification training** was completed July 1st. We have 75 current AMIAS's and 11 active Alateen meetings in Area 24

October 7, 2019 completed a training for new AMIAS's 6 attended and are in process of becoming certified.

Could a district approach the school system to see if they can get a meeting in a school? Yes, need people locally, especially AMAISs.

We can give Alateen 20 questions to school counselors.

There is a Teen Corner on our website. Meetings are best.

#### BREAK-OUT SESSIONS - Idalia

#### **Breakout Session on Service:**

Do you encourage people to do service? What are ways we can encourage service?

#### • Phil' group responses:

Encourage non-GRs to go to District meetings. Stepping into service can lead to conflict. Find solutions in that service role or in our everyday lives. Suggest the person might be great in that service role. Ask if they might be willing.

Encouraging sponsorship- use current person as a service sponsor. Use the service manual. Seek out people in the role you want to serve in. Taking on an additional role might be too much. Leave that service role if you move on, but be available for guidance.

#### • Erin's group responses:

Looking for some different thoughts about service. When people are in positions too long, it can be negative. What we've done if there isn't one person, ask people to share it. Be flexible. Ask people to join them when they go to a meeting, like an Assembly. Modeling behavior. Use service as a recovery tool.

#### **Breakout Session on the Appeal Letter:**

Do groups read the appeal letter? Do they mail contributions back in the envelope? How do you think the appeal letter could be approved?

#### • Lucinda's group responses:

Idea from the West Coast- Quarterly Appeal Jar, collecting all year around.

Idea from the Forum from 1992- broadness of WSO- what we did with literature in Russia and from Russia to America.

It would be good if we could also use a credit card.

Have others write the quarterly appeal letter with their stories.

Use the back of quarterly appeal letter to emphasize what we are doing with the money.

History of Al-Anon - we are not a fund-raising organization. This is different from the mail you might get at home.

#### • Mauria's group responses:

Every group reads and circulates the letter. What gets accomplished with the money?

The current letter is a spiritual letter, but too long. It can be distracting if it's being passed around.

Highlight important ideas- summarize. Service at the World level.

Something concrete- what are they using it for, how much,

Quarterly Appeal goes to CMA. Need to change if that person is no longer coming.

#### Treasurer's Corner

#### Contributions and 2019 Results

The contributions for the fourth quarter were \$3,389. The Area thanks you for all the group and district contributions. The expenses for the fourth quarter were \$1,194. The expenses were \$571 for Alateen support, \$250 for AWSC meeting expenses, \$188 for steering committee expenses, \$134 for printing and mailing of the Al-Anon-Cer, and \$67 for web and technology.

The total group and district contributions for 2019 were \$20,677. The area also received \$3,000 last winter from the Fall Convention from excess funds. Program expenses were \$13,640, which included \$5,000 in contributions to the WSO, \$1,836 in Alateen support, and \$5,151 spent to support public outreach. Administrative expenses were \$12,104, which included delegate expenses, Northeast Regional Delegate expenses, and insurance. As usual, insurance was over half of the administrative expenses. The deficit for the year was \$1,974.

The cash balance as of December 31 was \$24,779. This is about \$1,600 below the prudent reserve, which was set at the approved budget expenses for 2020, which are \$26,370. The Spring Convention account had a balance of \$4,794 and the Fall Convention account had a balance of \$8,334.

Our prudent reserve is a little below where we would like it. We had the opportunity to place Al-Anon public service announcements on buses and rail in Maryland this year. The assembly agreed that being able to take advantage of this opportunity was an important part of the reason we maintain a prudent reserve. Contributions from many groups and individuals helped replenish some of the funds spent.

#### **WSO Group Records Information Flow:**



REGISTER a NEW Group or UPDATE your Group's information at the WSO Website: https://al-anon.org/. Go to the WSO Homepage website, under the "Members" option, select Group Resources and the select under Group Records in the drop-down menu listing: https://al-anon.org/for-members/group-resources/group-records/

- WSO website allows members to UPDATE their WSO Group Record online. Completing the online Update form automatically generates an email to the AGRC for input within seven days of receipt. The AGRC sends copies of the updated record to the requestor for review and to the DR and AIS (when meeting is located in an AIS area) and to the member requesting the update and the CMA/GR.
- ❖ WSO website allows members to Register a NEW Al-Anon Family Group online. WSO requests that the AGRC verify the District of the meeting location before WSO finalizes the Registration. WSO THEN provides the WSO ID number for the New Group to the AGRC for them to notify the New Group's CMA/GR as well as the DR, and AIS where the meeting is located of the new meeting.
- ❖ WSO Annual Update Form reply: WSO now allows groups to send this form to the AGRC for update processing rather than the Group mailing it back to WSO for processing. Provide any changes to the Annual Update Form to the AGRC via phone, email or USPS. Contact information below)
